## 7. HANDLING AND STORAGE

**Handling:** Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of vapour, mist or aerosols.

## 10. STABILITY AND REACTIVITY

**Chemical stability:** Stable at normal temperatures and pressure.
